- ◆ Six fish per Team Crappie
- ◆ Live bait okay
- ◆ All Roosevelt Lake Park Rules and Regulations must be obeyed. Water safety must be a priority.

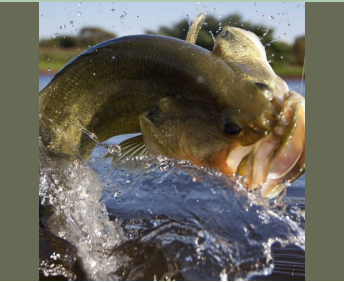
All registration paperwork and entry fees will be accepted on location
